555 Cordwainer: Susan Spratt, P.E., was again in attendance with the landscape architect and others members of the project team, relating to recent tree damage at the project site with request for removal per her email of 3/17/21. As requested, landscape plan revisions were provided showing new plantings, including eleven (11) trees, consisting of Green Giant Arborvitae and Redbud. After a short discussion, upon a motion duly made and seconded, Members

Brown, Rivkind, and Barbour were individually polled and **VOTED** unanimously to approve the modified Landscape Plans, dated August 28, 2020, as revised on April 9, 2021, as prepared by Verdant Landscape Architecture, signed and sealed by Katya Podsiadio, Registered Landscape Architect.
