Ellen Allen opened the meeting and introduced Jason Brown, Gregg McBride, David DeCoste, Tammie Garner and Town Administrator Jim Boudreau. Agenda Amended to postpone Code of Conduct, add the Town Administrator's Contract and Executive Session will not needed. *MOTION: Jason Brown moved the Board approve the agenda as amended. Seconded and unanimously voted.*

CITIZEN COMMENTS - None

Housing Authority Support Letter – Ellen Allen explained that she has received a letter from Sharon Sylvester who would like the BOS to send a letter of support for House Bill 1094 and opposing legislation offered by Governor Patrick. The legislation sponsored by the Governor consolidates local housing authorities into six mega-agencies controlled entirely by 9 Governor's appointees. This would eliminate local control. Nancy Dooley asked the BOS to support House Bill 1094, which keeps public housing locally controlled and accountable to the needs of residents. David DeCoste suggested that the Board draft their own letter.

Mary Cole – Town Hall/Library Study Committee Applicant – Mary Cole briefed the Board of Selectmen on why she is interested in serving on the Town Hall/Library Study Committee and what qualifications she could bring to that Committee. The Board thanked Mary and explained that appointments would be made after all applicants are interviewed.

Frank White – **Town Hall/Library Study Committee Applicant** – Frank White briefed the Board of Selectmen on why he is interested in serving on the Town Hall/Library Study Committee and what qualifications he could bring to that Committee. The Board thanked Frank and explained that appointments would be made after all applicants are interviewed.

Police Station Bid – Present: Chief Ted Ross and Rick Pomeroy, Owner Project Manager (OPM). Rick Pomeroy briefed the Board on the Bid Opening. Only two bids were received. They were in the amounts of \$4,798,718 from Mill City Contracting and for \$4,862,435 from G.V.W. Incorporated. The Board then had discussions on whether the Town should rebid after Town Meeting. The Board decided to support the OPMs recommendation on awarding Bid to Mill City Construction of Lincoln Rhode Island. *MOTION: Jason Brown moved that the Board of Selectmen support the bid for the Police Station to Mill City. Seconded and unanimously voted.*

Selectmen's Special Town Meeting Articles Discussion – The Board discussed the order of Articles that are submitted by them. Article 1 Contracts moved by Tammie Garner, Article 2 Police Station moved by Ellen Allen, Article 3 Zoning co-sponsored with the Economic Development Committee and Ellen will speak for this, Article 4 CPA reduction moved by David DeCoste. The Board discussed changing the order of Articles and Tammie Garner and Gregg McBride fully support leaving Articles exactly as arranged.
