7:45pm McGreal's Tavern – License Suspension or Revocation

Motion; made by Gregg McBride, seconded by Alison Demong, to open the public hearing about the potential license suspension or revocation at 7:45pm. Unanimously voted

Ms. Allen read the rules of the hearing from MA general law for cancellation of a license, noting the reasons for this hearing. Supporting documentation for this hearing is on file in the BOS office.

Ms. Allen stated that this will be an informal hearing. The rules of evidence will not apply but the hearing we be recorded. The licensees will be able to respond and present witnesses if they desire.

The license in question is a standard annual on-premise Common Victualer, All Alcohologouring license. Both Kevin and Mary Ann McGreal were present. Ms. Allen invited them to come forward to be sworn in by Fown Counsel Bob Galvin.

Mr. McGreal made comments and gave a short history of the business, stating that they were forced to close on 4/30/18. After considering different options, they offered the license to the new occupant, who declined because his business won't be opened until November at the earliest. The McGreals were notified by their landlord on 4/4/18 about their eviction from the premises.

They are requesting that the license not be revoked as they would like to turn it in. As they were only able to operate their business for four months, they would like to ask for a pro-rated refund from the Town. All expressed regret that McGreals has closed. Ms. Allen asked for comments from the board; there were none. Mr. Morin stated that he will work with the Finance Office to prorate the refund of the license fee. *Motion; made by Gregg McBride, seconded by Alison Demong, to close the public hearing at 7:55pm. Unanimously voted*

Motion; made by Gregg McBride, seconded by Alison Demong, to accept the return of the license for the premises of McGreal's Tavern and to refund the prorated annual fee for the period 1/1/18 to 4/30/18. Unanimously voted

All witnessed the license being turned in to Town Counsel at the close of the public hearing.
