Member Demong moved to approve the minutes of February 2, 2018 with changes. The motion was approved 6-0.

Discussion

1. Tier 3 CS Project Update: Member Demong inquired about CS Grant from MassDOT. We have been told letter is received but are now told that the grant will not apply until the next round of funding and not current one as we were originally told. State is saying they will look into with director. Town Administrator Morin is going to pressure state representatives to get answers.

Highway Surveyor Ferguson gave opinion on how far we could get if MassDOT funding does not come through. Also see what funds are available through the Town with current funds approved for \$100,000 from Planning Board if project was to move forward. Also would need to study the best placement for crosswalks. This would be the purpose of the MAPC Technical Assistance Request.

Member Demong motioned to vote on approval of funds for \$200,000.00 to be requested for at Town Meeting. Motion passed 6-1

2. **Main Street Warrant Article**: Member Bloomfield volunteered to speak at Town Meeting about the CS Grant Project and do a presentation.

3. **MAPC Technical Assistance**: Town Planner Kirkland has sent out technical request for crosswalk placement study to MAPC and waiting response. Will follow-up as well.

4. **Town Center**: The Committee needs to start looking at the Town Center Revitalization Project to come up with ideas and start process again.

Member Cafferty moved to adjourn meeting at 1:05. The motion was approved 7-0.
