Chair Bloomfield moved to approve the minutes of the November 16, 2018 Complete Streets Committee Meeting, as amended. The motion was approved 5-0.

Chair Bloomfield moved to approve the minutes of the January 25, 2019 Complete Streets Committee Meeting, as amended. The motion was approved 4-0.

Discussion

1. 2019 Town Meeting Funding Article: Chair Bloomfield stated that in his discussions with Town officials, he was informed that there was support for a sum of \$250,000.00 to be allocated for this project in the Town budget. This project being all aspects of sidewalk construction between Circuit Street and Lincoln Street on the North side of Main Street. Chair Bloomfield volunteered to draft an Article for the planning, design, and construction of a sidewalk from Town Hall to and through Town Center to include both phases, the first being Town Hall to Lincoln Street (Phase 3A) and the second beginning at Lincoln Street and concluding at the end of Town Center (Phase 3B). Member Campbell reviewed the construction costs with the Committee indicating that the final cost estimate for the work between Town Hall and Lincoln Street would total \$475,000.00, which included a 10% contingency. He added that estimates previously put forward by Highway Surveyor Ferguson and his own (Member Campbell) varied in the contingency amount used in the calculations of either 10% or 20%. Town Planner Kirkland stated that an additional \$25,000.00 would fund the engineering work from Lincoln Street and Town Center.

Chair Bloomfield put forth a motion to approve submitting an Article to request \$250,000.00 from Free Cash at Town Meeting for the planning, design, and construction of a sidewalk from Town Hall through Town Center on Main Street. The motion was approved 5-0.

Chair Bloomfield put forth a motion to approve submitting an application to request \$400,000.00 from the MassDOT Complete Streets Funding Program for the planning, design and construction of a sidewalk from Town Hall through Town Center on Main Street. The motion was approved 5-0.

Chair Bloomfield reviewed a PowerPoint presentation with the Committee that he is planning to present during the next Town Meeting in support of the Article. Members of the Complete Streets Committee provided feedback on the content of the presentation to Chair Bloomfield.
