THE PERMITEE SHALL INDEMNIFY AND SAVE HARMLESS THE HARBORMASTER AND THE MUNICIPALITY AGAINST ANY AND ALL CLAIMS OR OTHER CAUSES OF ACTION ARISING OUT OF OR IN CONNECTION WITH THE USE OF THE STRUCTURES AUTHORIZED HERBY.

IN THE EVENT OF FAILURE BY THE PERMITEE TO COMPLY WITH THE TERMS AND CONDITIONS OF THIS AUTHORIZATION, AND ANY FAILURE TO CORRECT SUCH NON-COMPLIANCE WITHIN A REASONABLE PERIOD AFTER WRITTEN NOTIFICATION BY THE HARBORMASTER, THIS AUTHORIZATION MAY BE MODIFIED OR REVOKED IN WHOLE OR PART WITHOUT LIABILITY TO THE MUNICIPALITY FOR COMPENSATION TO THE PERMITEE. UNAUTHORIZED STRUCTURES SHALL BE CONSIDERED A PUBLIC NUISANCE IN ACCORDANCE WITH M.G.L. CHAPTER 91S23 AND BE REMOVED AT THE EXPENCE OF THE OWNER
