## Norwell Planning Board Meeting Minutes January 22, 2014

The meeting was called to order at approximately 7:00 p.m. Present were Board Members Sally Turner, Darryl Mayers and Margaret Etzel. Brad Washburn and Ken Cadman were absent. The meeting was held in the Planning Office.

## **Draft Agenda**

Member Mayers moved that the Board approve the draft agenda with the elimination of the Executive Session as only three members were going to be present. The motion was approved by a vote of 3-0.

## Henry's Lane Surety Reduction

John Chessia revised the bond estimate at the request of Don Shute in December 2013. The estimate to complete dated 12/13/13 totals \$44,000. The Board currently holds a lenders agreement in the amount of \$145,000 for completion of the subdivision. Don is requesting a reduction in the surety from the Board for work completed in 2013 in the amount of \$101,000.

Member Mayers moved to reduce the surety by \$101,000 upon receipt of a new lenders agreement for \$44,000. The motion was approved by a vote of 3-0.

Public Hearing:

**Barrel Lane Subdivision Modification** 

Member Mayers read the public hearing notice at 7:30.

McKenzie Engineering (MEG) made modifications to the plans and drainage calculations as was discussed at the public hearing on January 8, 2014. Chessia Consulting's report identifies three remaining issues: (1) Proposed grading will cause storm-water to flow onto Circuit Street, (2) The pipe that connects the catch basins to the storm-water basin was not constructed in the center of the established easement and the new plan shows a building foot print directly adjacent to the easement and within a few feet of the pipe. (3) The proposal still includes clear cutting of the site.

The applicant will continue the meeting to 2/26/14 to address the outstanding issues.

*Member Etzel moved to continue the public hearing to February 26, 2014 at 7:30. The motion was approved 3-0.* 

### **ANR 101 Stetson Road**

Member Etzel moved to accept the ANR plan. The motion was approved 3-0.

## **ANR George Road**

Member Mayers moved to accept the ANR plan. The motion was approved 3-0.
