#### **Stretch Energy Code Discussion**

Building Commissioner Tom Barry was present to participate and comment.

Mr. Greenberg gave a summary of this building code and its problems. All but about 50 towns in MA first accepted the code as written and then updated in 2015. Adoption of the stretch energy code makes towns eligible as a Green Community members to receive state grants.

The alternative is the base energy code, which was updated in 2021. The Town could switch back to this code, whose requirements are not nearly as restrictive as the stretch code. Mr. Greenberg's fact sheet is attached to these minutes for more information.

Mr. Barry and Mr. Greenberg expanded on the two codes and gave examples of current building projects where compliance with the stretch technology made the cost prohibitively expensive.

One option would be to leave the Green Community program and let the consumer decide which code to use. Projects would still be eligible for MassSave rebates.

Mr. Greenberg proposed a Warrant Article to rescind the Green Community membership. A yes vote at Town Meeting would put this question on the ballot at the Town election.

Ms. Sullivan reported on the grant amounts and savings received since 2018. Per Mr. Greenberg, Norwell residents' spending on building projects to comply with the stretch code has far exceeded the grant amounts.

This topic will be on an upcoming meeting agenda for a vote when the Warrant is opened. Mr. Greenberg invited residents to comment.

# Appointment of Labor Counsel - Clifford and Kenney

The team from Clifford and Kenney introduced themselves to the board:

Atty. Kenney introduced everyone and gave a short history of the firm, which specializes in labor issues, contracts, etc. They have been in business for 11 years.

Attys. Messina and Williams introduced themselves and expanded on their specialties.

The firm represents most of the neighboring towns in Plymouth County and the south shore, so they know the area well. Their flat fee encourages more frequent client contact which promotes quicker resolution.

Questions were asked and answered about collective bargaining strategy. The firm will participate in labor negotiations for the time being to develop the strategy. They practice frequent updates and good communication. The firm could provide training to department heads and union training as requested.

Motion; made by Andy Reardon, seconded by Brian Greenberg, to appoint the firm of Clifford and Kenney as the labor counsel for the Town of Norwell. Unanimously voted
