## BOARD OF APPEALS Business Meeting Minutes May 17, 2017

JOINT MEETING WITH BoS: The meeting was called to order at approximately 6:45 P.M. in a joint-meeting with the Board of Selectmen to discuss requested fee reductions relating to the proposed "friendly" 40-B application on property located at 40 River Street, the site of the Town's former police station. The ZBA requested the joint meeting to learn the status of any and financial and/or other supports that have been or are proposed to be provided by the Town. Members wanted to determine whether any contractual obligations currently exist beyond the fact that the proposed use was voted by Annual Town Meeting. Members of the Board of Selectmen, primarily Gregg McBride and Jason Brown, indicated the funding for the proposed project will be coming from a variety of sources and there are currently no contractual obligations relating to waivers that the Board of Appeals could grant. Selectmen want to receive some tax revenue from the project.

There has been an increase in the original fourteen (14) units to eighteen (18) with reasons given to make the project "affordable". There appears to be some discrepancy between the ATM vote and current ambiguity about who might be able to live in the proposed apartment building, raised by Member Rivkind. The ZBA, therefore, requested copies of the original ATM Warrant article and any ATM handouts that the Board of Selectmen agreed to provide. Relevant copies of Community Trust Partnership minutes should also be provided.

The ZBA will likely need to look at the Town-provided and outside subsidies prior to granting any waivers relating to fees, taxes, and permits that have been requested by the non-profit developer. These financials will likely be reviewed early in the process.

No votes were taken relating to the proposed 40B project at 40 River Street.

**ROUTINE BUINESS MEETING AGENDA:** Members left the joint meeting with the Board of Selectmen at approximately 7:15 to begin their routine business meeting agenda in the Building Office.

<u>MINUTES</u>: Upon a motion duly made and seconded, members present **VOTED** to approve business-meeting minutes of May 3, 2017.

## DISCUSSION:

**239 WASHINGTON STREET 40B**: Chair Barbour will write a follow-up on report that Mr. Chessia had raised a concern that two parking spaces previously shown on the project plans appear to have been lost with the increase in number of units from thirtynine (39) to forty (40). Chair Barbour will follow-up with the Applicant.
