<u>NEW BUSINESS/CHAIR REPORT</u>: ZBA Annual Report – Upon a motion duly made and seconded, members **VOTED** unanimously to approve the 2014 ZBA report to the Town. The Chair advised the Town Planner forwarded a copy of the Planning Board's proposed amendment to §2300 District Use Regulations of the Zoning Bylaw, copies of which were distributed to members.

## OLD BUSINESS/STATUS UPDATES/LITIGATION: None discussed

<u>ADJOURNMENT:</u> The meeting was adjourned at approximately 7:35 P.M. with members Barbour, Brown and Rivkind moving to the gym for the scheduled public hearing.

<u>PUBLIC HEARING</u>: 81 Washington Park Dr. – SP/Sec 6 Finding – Upon motion duly made and seconded, members present unanimously VOTED to continue the public hearing to April 8, 2015. The members noted that the applicant is scheduled to meet with the Conservation Commission on 3/17 and that all setbacks are met except for the 35' frontage needed in Residential B. It was brought to the applicant's attention that if he can submit an amended plan, verifying what the front setbacks are of the abutters to the left and right of his property and take the average, and it is less than the 28.2', and the Board also has Conservation's comments, the Board would be able to make a decision without the applicant present if it is in his favor. Otherwise, the Board will continue the hearing so the applicant can be present.

Next Regularly Scheduled Meeting: April 8, 2015. The Board VOTED to cancel the March 18, 2015 meeting, which was subsequently reposted.
