Subsequently, one member suggested to the Chair that a former Planning Board member with an acknowledged wealth of ZBL history be invited to attend, which was accomplished.

A discussion ensued with Members Rivkind and Harrison raising substantive concerns. The Chair was instructed by the Board of Appeals at the close of the discussion to contact the chairs of the Planning Board and Advisory Board to convey its concerns and to request delay of further action until ZBA concerns could be adequately conveyed to the Planning Board.
