Open Session Minutes

Mr. Allen called the Open Session to order at 6:00pm.

Of note: Because this meeting was held in a fully remote manner, all votes were done by roll call.

Ms. Horowitz moved to open the meeting at 6:00pm, and Ms. Osborne seconded. Mr. Allen, Ms. Osborne, and Ms. Horowitz voted in favor of the motion.

The Board voted on the Open Session minutes from the 10/26/20 meeting. After proposing a brief amendment to delete names of community participants from the minutes, Ms. Osborne moved to approve the minutes as amended, Ms. Horowitz seconded the motion, and Mr. Allen, Ms. Osborne, and Ms. Horowitz voted in favor of the motion.

The Board went through current accounts payable, as follows:

- For a total current accounts payable of \$2050.25

Ms. Horowitz moved to approve these bills, Ms. Osborne seconded the motion, and Mr. Allen, Ms. Osborne, and Ms. Horowitz voted in favor of the motion.

The Board reviewed the monthly reports, and after doing so, Ms. Osborne moved to accept them as presented. Ms. Horowitz seconded the motion. Mr. Allen, Ms. Osborne, and Ms. Horowitz voted in favor of the motion.
