
Norwell Board of Selectmen Open Meeting Minutes 4/24/19



Present: Ellen Allen, Gregg McBride, Jason Brown, Joe Rull, Peter Morin

Ellen Allen cailed the meeting to order at 7:00pm in the Selectmen's Conference Room

The minutes of March 6, 20 & 27 were unanimously approved by the Board.

Ms. Allen shared that the Garden Club is trying to schedule use of the Osborn Room starting next Fall for one Thursday each month from 12-2. They need a new space because the temporary library doesn't have a meeting room. The Town Clerk told them that the Selectmen need to approve this. Mr. Morin said he wants displaced groups to use the Cushing Center (CC). It was noted that the CC charges fees for use, as well as the cost of the custodian; groups who have used the Library in the past have not needed to pay for these. Mr. McBride and Mr. Morin will follow-up with the CC Directors. The Board agreed that the Garden Club may use the Osborn Room, which Ms. Allen will communicate to them and the Town Clerk.

An Eagle Scout is coordinating with Glenn Ferguson to add a handicapped accessible ramp at the Town Common for his Eagle Project. The Board expressed support.

The meeting was called to order by Chair Ellen Allen at 7:30pm. She reminded all that the meeting is televised and recorded. All rose to recite the pledge of allegiance.


Selectmen Announcements

Discussion/Action Items

4c. BOS discussion and approval – Friends of COA memorial bench on Town Common Ms. Allen gave a brief summary of Dorothy Dixon's long and valuable service record, both serving our country in the armed forces and also as a long-time resident and volunteer in the Town, State and Veterans Services. She was Citizen of the Year in 1997. The memorial mass for Ms. Dixon will be May 1st at 10am at St. Helen's.

Pat Butler, President of the Friends of the COA (FOCOA), and Caroline LeCroix were present to give a short summary of the FOCOA's proposal to honor Ms. Dixon's memory and veteran status with a granite bench on the Town Common. Ms. La Croix noted that Ms. Dixon started the COA in the Town. The bench will have a small plaque in her honor. All talked about the placement of the bench on the common, which will be sited by Glenn Ferguson. The board is in favor of this thoughtful gesture in memory of Ms. Dixon and her significant contributions to the Town.

Motion; made by Gregg McBride, seconded by Jason Brown, to approve the granite bench in memory of Dorothy Dixon, to be placed by the Highway Surveyor in an appropriate location on the Town Common. Unanimously voted

The board thanked Ms. Butler and Ms. La Croix for coming in.

Road Race Application - Ride for Habitat, September 14, 2019

Ms. Allen noted that this is the 13th year of South Shore Habitat for Humanity's ride in the Town. It winds through Norwell in various locations, and will be held on 9/14/19, from 9am-11:30am. The Police Department would like contact information for race day. All are in support of this race.

Motion; made by Gregg McBride, seconded by Jason Brown, to approve the race application for South Shore Habitat for Humanity's Ride for Habitat on 9/14/19, with conditions as noted by the Police Department. Unanimously voted

Mr. Brown asked about event fees being charged by the Town – are any being collected? Mr. Morin replied that for-profit organizations are charged a fee and all are required to pay for the cost of their police details. Races impacting only a part of the Town are charged a smaller fee. Mr. Brown asked if the Town's expenses were being covered – answer, yes. The event fee has dramatically increased and all applicants were notified a year in advance. The larger for-profit events that are run predominantly in the Town are charged the higher fee. The charity events are charged less.

Small Cell Wireless Installations Policy

Ms. Allen announced that the rollout of 5G services is beginning in the country. The FCC has released a wireless preemption order to get these services in place as quickly as possible. Carriers can put them in the public right of way with very little limitation or town approval, effective 4/15/19.

The board reviewed a memo and draft policy from Town Counsel that puts a policy in place for an application process and content. It takes the limited authority of the Town and puts it on paper. Zoning is largely overridden by this FCC ruling and there are no aesthetic limitations. This policy will go on the Warrant for the next Town Meeting to be adopted as a bylaw. It will be better than having no policy in the bylaws and will include information on applications to the BOS, some fees structure, rules for public hearings, time limits, required information, renewal process and the limited regulations (such as no double poles). The board wanted to warn residents that these installations may be unsightly, but communication will be better. Per Mr. McBride, the carriers are rolling out these services in limited numbers and mostly in cities. This adopted policy can also be customized or edited as needed over time.

Motion; made by Gregg McBride, seconded by Jason Brown, that the board adopt the policy for applications for small cell wireless installations as drafted by Town Counsel. Unanimously voted 2019 MAY 23 AM 9: 26
