# Norwell Community Housing Trust Meeting Minutes January 21, 2021

The Community Housing Trust was called to order by Gregg McBride, Chair at 7:30 pm. Also present were Liz Hibbard Vice Chair, and Board Members Peter Shea, Cara Hamilton, Ellen Allen and Leanne Walt. Unable to attend, Rob Charest. Guests included Vcevy Strekalovsky. The meeting was held remotely, as allowed under the Executive Order dated March 12, 2020 suspending certain provisions of the Open Meeting Law, Gen. L. c. 30A §20 et seq. and 940 CMR 29.01 et seq.

#### ADMINISTRATIVE MATTERS

Motion made to accept the Agenda of January 21, 2021. Seconded and passed 6-0-0 by roll call vote.

Motion made to approve the minutes of January 7, 2021. Seconded and passed 4-0-2 by roll call vote.

#### CARLTON PROPERTY DISCUSSION

Vcevy Strekalovsky, Strekalovsky Architecture, discussed the conceptual designs and site plans he submitted prior to the meeting.

Site Plan A consists of 5 larger style homes with 4 units in each with 1,2 and 3 bedroom units within.

Site Plan B consists of 4 larger style homes with 2 homes having 4 residences within and 2 homes having 5 units within. All including 1,2, and 3 bedroom units.

All Members agreed this first rendition was very consistent with what the Trust Members had asked for in terms of size, scale, unit totals. A 3<sup>rd</sup> option & a finished street view was requested. Vcevy was hoping to have the changes ready for our next meeting.

Ellen Allen suggested preparing the Article for the Warrant for the Carleton Property to transfer care, custody and control of the land situated on Lincoln Street, consisting of approx. 9.3 acres to the Community Housing Trust for the purpose of affordable housing.
