
Community Housing Trust

Open Meeting Minutes

July 30, 2019

The meeting was called to order by Gregg McBride at 7:00pm.

Update on Wildcat:

A discussion ensued about the obstacles ahead for the Wildcat Project, re: funding, Pro forma, research development grants, CPA funding and need to retain Counsel.

Circuit Street:

The 2.5 acres in the area of Parson's Walk, frontage on Circuit St, property is under review as a possible candid for a Road to Responsibility or possible Habitat for Humanity. The property is in the process of being moved into the Housing Production Plan. Agreement that the property could be a good opportunity for housing. The Trust will formally express interest to the Board Of Selectmen, who control the property.

Housing Production Plan:

Gregg McBride has made the necessary edits to the document, incorporating the Town Planner's suggestions. The draft has been provided to the Planning Board and Board of Selectmen for review and signature.

Small Grant Program for Seniors:

Andy Reardon will be updating the application form with Council on Aging and Ellen McKenna will post to website when completed. COA reports that there are several people inquiring about the program and application.

Carlton Property:

As requested by the Carlton Committee, the Community Housing Trust is considering the parcel of land on Lincoln street. The USGS Soils map, the "B" area on the Mass GIS map. The idea of preserving the land for future development of affordable housing.
