Community Preservation Committee Meeting Minutes January 14, 2021

The Community Preservation Committee was called to order by Chair, Julie Gillis at 7:06 pm. Administrative Matters

Funding Applications

Completion of the Bike Path to Town Common (8)

Glenn Ferguson, Highway Department Supervisor, submitted an application for \$403,5k to complete the bike path to the Town Common. The application also includes a 270ft wood foot bridge and pathway connecting Garfield Park along River Street to Norris Reservation.

Section 1 - to the Town Common is \$123k

Section 2 - to Norris Reservation total is \$280,500k

Community Housing Trust

Gregg McBride, Chair, was invited back to discuss the Community Housing Trust (CHT) application for \$100k and Genevieve Davis shared her thoughts on the possibility of increasing the application amount.

Proposal for Prospect Street Appraisal

Ellen Allen shared information about a meeting with Brian Murphy, the current owner of the Prospect Street Property. Currently, Mr. Murphy has a permit with ZBA to build a large multi-unit development apartment building but was interested in exploring the possibility of selling the property to the Town.

Motion made to approve \$7500.00 from the Administrative Fund for the Appraisal of approximately 28.72 acres on Prospect St. by Realworth Appraising and Consulting. Seconded and passed 8-0-0. (Bob McMackin recuse himself)
