# Five Year Action Plan Update

---

## HIGHLIGHTED ACCOMPLISHMENTS

The Town of Norwell has accomplished many goals identified in the 2005-2010 Open Space Plan. The attached documents provide more detail and outline progress that has been made since the 2005-2010 Open Space and Recreation Plan was written. Notable accomplishments include:

- Stetson Meadows (120+ acres on the North River) has been surveyed and will be recorded as Conservation Land.
- The Norwell Water Dept has partnered with the North and South River Watershed Association (NSWRA) to educate Norwell citizens on water conservation. A portion of the Water Department budget supports the work of the Greenscapes MA Coalition, a part of the Massachusetts Bays Estuary Association, through the North and South Rivers Watersheds Association. The Coalition has created guidance on mowing, pesticide alternatives, fertilizing alternatives, composting, lawn watering, automatic irrigation systems, planting beds, low maintenance plants, managing stormwater, rain gardens, and urban gardening. This guidance is placed into water bills and is published in a 20-page reference guide that is circulated through the Town.
- The Norwell Conservation Commission now has a full time Conservation Agent.
- The Town of Norwell coordinated with the NSRWA to conduct a seminar for the purpose of educating private and non-profit land owners about land protection strategies and tools. The Conservation Commission is planning to seek CPC funds for future seminars.
- Community Preservation Act contributions have continued at the original funding level (3%) for the last 5 years.
- Since 2005, Norwell Town Meeting has designated the following 17 Scenic Roads: Central Street, First Parish Road, High Street, Old Oaken Bucket Road, Prospect Street, River Street, Circuit Street, Green Street, Lincoln Street, Pine Street, Pleasant Street, Mt. Blue Street, Wildcat Lane, Winter Street, Summer Street, Forest Street and Cross Street. Norwell currently has 23 designated scenic roads in total.
- Norwell Town Meeting approved a Open Space & Recreation Residential Design (OSRD) Bylaw to promote new development that fits in with Norwell's semi-rural character. The first OSRD project is currently in the permitting process.
- Community Preservation Act funding was used to improve access to the North River at the Bridge Street & Chittenden Lane Landings. The Bridge Street Landing was completed in 2008, and offers a new ramp, a re-graded and resurfaced parking area and driveway, two benches that overlook the river, and trash receptacles. The Chittenden Lane

Landing was completed in 2009, which increased the parking from one space to four, added a new dock, access to the river, benches, and trash cans, and resurfaced and regraded the driveway as well as restored an area of salt marsh with Spartina.

- The Norwell Planning Board appointed a Pathways Committee to design a bike path in Norwell. This Committee is in the process of designing the trail and has secured funding to hire engineering services to design a portion of this path.
- 20 new vernal pools were certified with the Natural Heritage and Endangered Species program between 2005-2009 (see appendices for map and list).
- Five properties totaling 27.68 acres were purchased for the purposes of conservation.

<sup>i</sup>The Massachusetts Statewide Comprehensive Outdoor Recreation Plan (SCORP) is a broad planning document based on six priority areas: Resource Protection, Stewardship, Restoration and Enhancement; Education and Information; Partnerships; Funding; Access; and Maintenance. The Plan offers policy reports on each of those areas and many of the goals and objectives are similar to, if not the same as, this plan. SCORP is a state-wide document and has been written to be applicable to cities and towns across the Commonwealth. Therefore, while the SCORP does not call for the development of a management plan specifically for Fog Forest in Norwell, it does call for developing "action plans for areas of multiple use to mitigate adverse impacts and avoid user conflicts."

<sup>ii</sup> The Clean Water Act authorizes the EPA and states to regulate point sources that discharge pollutants into waters of the United States through the National Pollutant Discharge Elimination System (NPDES) permit program. "Point sources" are generated from a variety of municipal and industrial operations, including treated wastewater, process water, cooling water, and storm water runoff from drainage systems. The NPDES Phase I Storm Water Program (in place since 1990) regulates cities and counties with populations of 100,000 that operate a municipal separate storm sewer system (MS4), specific industrial operations, and construction activities that disturb 5 or more acres of land. The Phase II Storm Water Program (effective March 2003) regulates MS4s located within "urbanized areas" as defined by the U.S. Census Bureau and construction activities that disturb between 1 and 5 acres.


