Wompatuck Park Discussion:

Landscaping and Fencing concerns:

Ilana Quirk -Open Space and Recreation Committee is currently working on guidelines for as of right benches. Kevin Cafferty will send an email including a company he has had success with.

Will Saunders is watching the plantings as there is a one-year warranty. Will is also suggest waiting to plant additional plants for two years.

Will Saunders updated the Committee with the remaining balance for this project (80K) A discussion ensued regarding the guardrail vs. large rock vs. fencing to keep the parking lot safe around the paver forebay area's and the constraints were discussed in the area of National Grids access.

Motion: to authorize fencing and guardrail work not exceed \$5K for wooden guardrails around paver forebays and post and rail wooden fencing with a chain in the space for National Grid access seconded and unanimously voted 6-0.

Possible CPC Application

Masthead Drive, North River Access:

The Pathways Committee discussed the potential Masthead Project this evening and the Committee does wish to try to go forward with a very limited project (not extending to Stetson Meadow). A limited access way and small parking area and a canoe/kayak launch. Ilana Quirk, will ask to add this topic to the next agenda for the Conservation Commission meeting on October 4, 2022 6:30pm. Brendan S. described the project to be a very small lot with a lazy path to access the river for canoes and kayaks and suggested this with a small 10-20 car lot. Brendan described the River as Norwell's best asset and Bridge Street, and Chittenden Lane are currently the only public points for access. Ilana Quirk and Brendan S. plan to walk the area and attend the Conservation meeting.

Motion: made (by Kevin Cafferty) for Engineering Services for the Masthead Meadows access to the River if Conservation agrees at their next meeting. Seconded (Brendan Sullivan) and unanimously approved.

Vinal School Trails:

Members were talking about walking the trails on Samuel Woodworth Road that lead to Vinal School for possible improvements.
