- **Vinal School/Samuel Woodworth Walking Path**

Ilana Quirk recently walked the site. She described the pathway as roughly 6' wide and said the subdivision portion of the path, roughly 300' is not in terrible condition - but the point where the path leaves the subdivision and crosses over the property boundary line with the Vinal School property, that portion of the path needs design and construction work that will be a challenge as this portion of the path is steep and appears to have been created by people walking on it.

She reviewed the 1969 subdivision decision and it refers to an easement for the path; however, she did not find an easement. She will perform some more digging. The HOA may hold an easement.
