- 4. **RFP Middle to High School.** (Discussion came after item # 8 below). Questions raised by KC regarding language (KC arrived at 8:40 PM) consensus to request TT to ask TA if one sentence can be removed. Also change date of meeting to 03 Nov 09, with TT to handle same.

SR and DV to contact owners, and present information to them. RT said that he would copy members with PDF. SI noted that an orthophoto might assist, that shows location of structures on site with respect to the proposed alignment of pathway.
