April 3, 2019 PC Meeting Minutes

Chair Cafferty moved to approve the minutes of the April 3, 2019 Pathway Committee Meeting. The motion was approved 5-0.

Discussion

- 1. Whiting Fields Site Visit with Carleton Property Committee & Complete Streets
 Committee: The site visit is scheduled for June 17th at the Whiting Fields. Member
 Sullivan showed a plan for the Property with two (2) potential parking locations
 identified. One was to the west of the abutting property on Lincoln Street and the second
 was situated at Fogg Forest, accessible from Main Street on the east side of the Property.
 The plan also showed a potential Main Street crossing situated between Homestead Farm
 Drive on the north side and near Jordan Lane on the south side of Main Street. Member
 Sullivan suggested that sizing the lots for ten (10) cars each were the initial thoughts.
 Chair Cafferty discussed expanding the plan to twenty (20) car capacity in either one or
 both lots. Member Kelliher suggested that waiting to see how heavily the Property and
 lots would be used should precede any plans for providing parking or pathway areas on
 the Property.
- 2. Wompatuck Entrance & Parking Lot Alternative Berm Layout / Design Discussion: Chair Cafferty asked if the plan for the entrance was ready to go out for bid

as is. Town Planner Kirkland stated that he would ensure Horsley Witten Group include the re-designed berms in their plans. He also added that another letter had been sent to National Grid with a request for response within 30 days and that the project would move forward if no response is received.

3. Pedestrian & Bicycle Pathway Phase III – Overall
Progress Undate: Chair Cafferty requested an undate

Progress Update: Chair Cafferty requested an update on the progress of the Gaffield Park parking and pathway connection. Town Planner Kirkland stated that the last update from Highway Surveyor Ferguson was that he was all set to move forward. Member Sullivan asked for clarification on the pathway/ boardwalk route going to both Town Center and Norris Reservation. Town Planner Kirkland confirmed that it is a "wishbone" or Y-shape from the River Street boardwalk terminus, one up River towards Town Center, and the other from Dover to Norris Reservation.

- 4. <u>Gaffield Park Potential Parking / Pathway Connection Overall Progress Update:</u> Chair Cafferty stated that primary funding would come from the Recreation Department for this work with additional funds possibly being contributed by Pathways if leftover from Phase III work.
- 5. <u>Eagle Scout Project Installation of Workout Station near Eagle Scout Benches</u>: Town Planner Kirkland sent email correspondence to the Eagle Scout and has not received a response. This item is to be closed out at this time.
