APPLICATION FILING INSTRUCTIONS

- 1. Submit one (1) original, and one (1) copy of the fully executed **Form S** application to the Planning Department.
- 2. Submit to the Planning Department a minimum of two (2) photos of the site showing the existing conditions and the scope of the proposed work (digital photos via email are acceptable). The photos showing the proposed work should depict the areas of disturbance, with the appropriate flagging pursuant to §2 of the Scenic Road Bylaw. Such flagging should include ribbons around trees slated for removal and ribbons or stakes at each end of the proposed stonewall breach.
- 3. Submit a plan or drawing showing the proposed work, including additional stonewall or tree disturbance due to the potential installation of electric, water and gas lines.
- 4. Submit one (1) original, fully executed **Form S-4** application (included in this packet) documenting the names and addresses of all owners of land directly abutting upon the land, including those separated by a street from the subject property as appearing on the most recent tax list and as certified by the Town Assessor.
 - a. The public hearing will **<u>NOT</u>** be advertised until the Assessor's Office has signed this document.
 - b. The Applicant shall mail copies of the legal notice to the abutters by certified mail and provide proof of mailing to the Planning Board **prior** to the opening of the public hearing.
- 5. Submit one (1) original, fully executed **Form S-5** (included in this packet) documenting the Applicant's contact information required for the billing of the public hearing notification pursuant to §6b of the Scenic Road Bylaw. The Planning Department will publish the legal notice in the newspaper. **The Applicant is responsible for the advertisement fees**.
- 6. Please note that if the Town Planner or the Planning Board finds the proposed work to be significant, additional submittals may be required including a sketch plan or more formal engineered plans per §6.4 of the Scenic Road Bylaw.




