## Norwell Planning Board Meeting Minutes March 11, 2015

The meeting was called to order at approximately 7:00 p.m. Present were Board Members Darryl Mayers, Ken Cadman, Brad Washburn, Patrick Campbell and Peggy Etzel. The meeting was held in the Planning Office.

## Draft Agenda

Member Etzel moved that the Board approve the draft agenda. The motion was approved by a vote of 4-0 (Member Campbell had not arrived yet).

#### **Minutes**

10/22/14 Minutes: Member Etzel moved that the Board approve the minutes. The motion was approved by a vote of 3-0 (Member Campbell had not arrived and Member Cadman recused himself).

11/5/14 Minutes: Member Mayers moved that the Board approve the minutes. The motion was approved by a vote of 3-0 (Member Campbell had not arrived and Member Etzel recused herself).

Member Etzel moved that the Board approve the bills. The motion was approved by a vote of 4-0 (Member Campbell had not arrived yet).

## **Public Hearing: OSRD**

The Board is proposing several modifications to the OSRD bylaw including clarifying language on waivers, the process for pre-application conferences, the open space requirements, establishes a new vegetated buffer for shorter subdivision roads, reduces the

width of streets to 24 feet and requires the submission of a traditional subdivision plan along with the OSRD plan.

Member Etzel moved to approve amendments to section 4850 as amended on 3/11/15. The motion was approved by a vote of 5-0.

### Public Hearing: Solar Photovoltaic Overlay District

The Board is proposing to establish an overlay district that would allow large scale ground mounted solar installations (larger than 1 acre) by right. The district would include both Business C districts and a parcel of Water Department owned property off of South Street.

Member Campbell moved to approve the establishment of the district as amended on 3/11/15. The motion was approved by a vote of 5-0.

#### **Public Hearing: Business Use Table**

The Board is proposing to replace existing business use sections in the zoning bylaw with a use table in the attempt to make the by-law more user friendly and streamlined.

Member Mayers moved to approve the use table as amended on 3/11/15. The motion was approved by a vote of 5-0.

Member Etzel moved to close the public hearings on the zoning amendments. The motion was approved by a vote of 5-0.

#### **Barrel Lane HOA**

The applicant, Toll Brothers, with the approval of Don Shute, are proposing a modification to the HOA documents. Attorney Galvin have reviewed the documents and finds them acceptable.

Member Cadman moved to approve the revised HOA document. The motion was approved 4-0 (Member Mayers abstained).

#### 22 Forest Street

The Pathways Committee is attempting to purchase a small piece of land off of Forest Street that could provide a trail connection between Miller Woods and First Parish Church property at the town center. The committee is requesting \$1,500 from the Pedestrian Enhancement Fund to make an offer on the property.

Member Cadman moved to approve the \$1,500 expenditure from the Pedestrian Enhancement Fund. The motion was approved 5-0.

#### ADJOURNMENT

At 8:30 p.m., Member Mayers moved that the Board adjourn. The motion was approved by a vote of 5-0.
