Norwell Estates – Stormwater Basin (Lot 4) – Commission Discussion (Present for this meeting was David Buckley of Toll Brothers)

The Commission reviewed the email(s) from engineer John Chessia (of Chessia Consulting) regarding recent inspection of the (Lot 4) Basin seeking release.

Per Mr. Chessia's comments:

"Toll Brothers did the work as discussed in various emails and on-site last week. Everything looks good. As they proposed sod was cut from the top of the berm and placed in the two areas requiring stabilization in the bottom one near Lot 4 and the other near the berm on the far side opposite the forebay. This material is the same as used throughout the basin and has shown it will grow in a wet environment. Higher areas were stabilized with standard lawn grass sod. It is still a big soggy in the area on Lot 4 near the temporary basin. It would make sense to look at it next Monday to see if it has died or if it has green shoots. I think it would be reasonable for the Commission to OK it subject to a reinspection in a week. If the material has died then they would need to come up with another solution and if it looks good they should be all set to implement the switch to the permanent basin. It should not take long to see if it takes and probably not necessary to wait for another meeting of the Commission but that is up to the Commission to decide. This week the weather looks favorable for it to establish. They have irrigation from the temporary basin for the sod on the slopes and top of berm and should check the other lower areas to see if watering is necessary but there is likely more than enough water already there".

Motion by Mr. Mott to release (Lot 4) stormwater basin, provided it complies with Mr. Chessia's requirements/comments. Seconded by Ms. Markham and approved by unanimous vote.
